

LICENSE & INDEMNITY BOND

KNOW ALL MEN BY THESE PRESENTS, that I/we, _____
_____ as principal, and _____
_____ as Surety or as Sureties, are held and firmly bound to the City Council
of Augusta, Georgia, and any person described herein, in the penal sum of One Hundred
Thousand Dollars (\$100,000.00), for the payment of which well and truly to be made, we
jointly and severally bind ourselves, our heirs, executors, administrators, personal
representatives, successors and assigns, firmly by these presents.

The conditions of this obligation are such that, whereas the above bound
Principal has this day made and does hereby make application for a business license to
operate as a dealer in second-hand jewelry, gold, silver, etc., in the City of
Augusta, for the calendar year (or remaining portion thereof) ending with the 31st day
of December, _____.

NOW, THEREFORE, in consideration of said occupation tax receipt being issued to
the Principal, the said Principal shall:

1. Indemnify and save harmless the City Council of Augusta, Georgia, its officers
and employees, and their successors from and on account of any and all
judgments, claims, demands, losses, costs, expenses or liabilities of any kind
whatsoever which said City, or any or all of the persons above enumerated may
sustain or which may be recovered from it or them, from or by reason of the
issuance of such business license or by reason of any act, neglect, or thing
done under or by virtue of the authority given such business license;
2. In all respects be bound hereby to any and all applicable requirements and
provisions required to be in this bond by existing and hereafter existing
ordinances, rules and regulations of the City Council of Augusta, Georgia, and
other laws, the same as though such requirements and provisions were fully set
forth in this bond, and by reference such requirements and provisions are made
a part hereof;
3. Comply with and faithfully observe and obey all applicable rules and
regulations and ordinances of the City Council of Augusta, now or hereafter
existing affecting or relating to the maintenance and operation of a dealer in
second-hand jewelry, gold, silver, etc.;
4. Pay any penalties that may be imposed during and for the period of said
business license;
5. Pay all damages or losses as may be incurred by the true owner of any item in
second-hand jewelry, gold, silver or precious metals and which are evidenced by
a final civil judgment against the said principal, rendered by a court of
competent jurisdiction for: (1) violation of any law or ordinance of the City
Council of Augusta now or hereinafter in effect for the purpose of regulating
dealers in the business of buying second-hand jewelry, gold, silver or precious
metals or (2) the torsions conversion by the principal of any item in second-
hand jewelry, gold, silver, or precious metals;
6. Not conduct his or her business at any other place than the one named in said
license, nor permit any minor under the age of eighteen (18) years of age to do
such business.

Compliance with all and several of the above enumerated items shall make this bond
void; otherwise, it shall remain in full force and effect.
