KNOW ALL MEN BY THESE PRESENTS, That we, \_\_\_\_\_  
\_\_\_\_\_ of the County of \_\_\_\_\_, State of \_\_\_\_\_, as Principal, and \_\_\_\_\_, as surety, a corporation duly organized and existing under and by virtue of the laws of the State of \_\_\_\_\_, are held and firmly bound unto the CITY OF CAIRO, GEORGIA, in the full and just sum of One Thousand Dollars (\$1,000.00), lawful money of the United States of America, for the payment of which well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents; and

WHEREAS, the said principal has been or is about to be licensed as a Gas Fitter by the City of Cairo, pursuant to the ordinances of said City,

NOW THEREFORE, the conditions of this obligation is such that if the said principal shall protect said City against all loss or damage occasioned by the negligence of the principal therein in failing to properly execute and protect all work done by him or his employees, or under his direction or supervision, and from all loss or damage occasioned by or arising in any manner from any such work done by said principal or his employees or under his direction or supervision, which is not caused by the negligence of said City or its Agents or employees; and, said principal herein will keep and observe all ordinances now existing or at any time enacted by said City relating in any way to gas installations; and, without additional cost to the person for whom the work is done, remedy any defects therein due to faulty workmanship and incorrect construction or due to faulty material furnished or used by such principal and shall reconstruct and repair such work to the satisfaction of the City Gas Inspector of the City of Cairo (Georgia) at any time within one (1) year after the construction, repair of installation thereof, and after forty eight (48) hours notice from the City Gas Inspector to reconstruct or repair the same; and shall discharge the duties of a gas fitter well and truly, then this obligation to be void; otherwise in full force and effect.

The term of this bond shall be from \_\_\_\_\_ to \_\_\_\_\_ and may be continued from year to year by continuation certificate issued by the surety. If the surety so elect, this bond may be cancelled by giving thirty (30) days notice in writing to the City of Cairo, Georgia, and this bond shall be deemed cancelled at the expiration of thirty days after such notice has been given, with the surety remaining liable for any act or acts committed up to the date of such cancellation, under the terms of this bond.
