Now, therefore, if the above-bound Principal sufficiently and honestly pays the City of Chicago all fines and penalties that the COMMISSIONER, DEPARTMENT OF BUILDINGS in accordance with the provisions of Chapter 4-36 of the MUNICIPAL CODE OF THE CITY OF CHICAGO, may impose upon the Principal from or by reason or on account of anything done under and by virtue of any permits issued under the license, then this obligation will be null and void, otherwise, to remain in full force and effect.
