NOW THEREFORE, THE CONDITIONS OF THIS OBLIGATION IS SUCH THAT IF A LICENSE IS GRANTED TO THE SAID _____, AND IF SUCH LICENSE SHALL DURING THE LIFE OF SAID LICENSE, PROMPTLY PAY TO THE CITY OF FORSYTH FOR ITS USE ALL SUMS WHICH MAY BECOME DUE BY SAID PRINCIPAL TO THE CITY OF FORSYTH AS TAXES, LICENSE FEES, OR OTHERWISE, BY REASON OF, OR INCIDENT TO THE OPERATION OF SAID BUSINESS TOGETHER WITH EXPENSES INCURRED BY THE CITY IN THE COLLECTION OF ANY AMOUNT DUE THE CITY THE AMOUNT OF EXPENSE TO BE DETERMINED BY THE CITY COUNCIL BUT NOT TO EXCEED ONE HUNDRED (\$100.00) DOLLARS, AND SHALL FAITHFULLY COMPLY WITH ALL LAWS, RULES AND REGULATIONS GOVERNING THE SALE OF ALCOHOLIC BEVERAGES AS REQUIRED BY THE CODE OF THE CITY AND STATE, AND SUCH OTHER CONDITIONS AS THE CITY OF FORSYTH MAY BE ORDINANCE, RULES, REGULATIONS AND POLICY REQUIRE, THEN THIS BOND SHALL BE VOID; OTHERWISE, TO REMAIN IN FULL FORCE AND SHALL BE CONSTRUED AS A FORFEITURE BOND.

THIS BOND SHALL BE IN FORCE FOR THE AFORESAID PERIOD OF SAID PRINCIPAL'S MALT BEVERAGE LICENSE. IT IS UNDERSTOOD AND AGREED THAT THIS BOND MUST BE CONTINUED BY CONTINUATION CERTIFICATE SIGNED BY THE SURETY, UNLESS THE BOND EXPRESSLY DECLARES THAT IT IS ONE OF A CONTINUOUS NATURE.

IT IS FURTHER UNDERSTOOD AND AGREED THAT IS THE SURETY SHALL SO ELECT, THIS BOND MAY BE CANCELED BY GIVING SIXTY (60) DAYS NOTICE IN WRITING TO THE CITY CLERK OF THE CITY OF FORSYTH, GEORGIA.
