determined by the Obligee but not to exceed ONE HUNDRED (\$100.00) DOLLARS for the period covered by this bond, and shall, in the operation of said business, faithfully comply with all provisions of said Resolution, as amended and with all rules and regulations now, or hereafter, promulgated by the City Council under the authority of said Resolution as amended, for the enforcement and administration of said Resolution and with such other conditions as the City Council may require in rules and regulations, then this bond shall be void; otherwise, it shall remain of full force and effect and shall be construed as a bond of forfeiture.
