

CONTRACTOR'S BUILDING CODE COMPLIANCE BOND

KNOW ALL MEN BY THESE PRESENTS:

That we, _____ as Principal, and _____ as Surety, are held and firmly bound unto the Governing Authority of Gwinnett County, State of Georgia, and their successors in office in the just sum of TWENTY-FIVE THOUSAND AND NO/100 (\$25,000.00) DOLLARS, for the payment of which well and truly to be made, we bind ourselves, our heirs, executors and administrators, each and every one of them, jointly and severally, firmly by these presents.

It is further understood and agreed that this bond is continuous beginning on the 1st day of _____, _____.

The condition of the above obligation is such , that;

Whereas, the above bound Principal has made application to the Governing Authority of Gwinnett County for a license as a Contractor in accordance with the rules and regulations governing contractors in Gwinnett County, Georgia;

It is a further condition of this bond that the said Principal is to comply with all of the requirements and provisions of the Building Code of Gwinnett County, and a further condition of this obligation is that the Principal and Surety to this bond shall be subject to suit by action thereon by the Gwinnett County Board of Commissioners, if in the discretion of the Chief Building Inspector of Gwinnett County, it has been determined that said Principal has violated the Building Code of Gwinnett County, or any provision thereof, for the purpose of requiring the necessary expenditure of funds to correct said building code violation(s) on the part of said Principal, his agents or employees. Said Principal is hereby bound under said bond to faithfully perform all of this duties as such Principal and Contractor in compliance with the Building Code of Gwinnett County, and all other ordinances of Gwinnett County relating to buildings and the construction thereof.

Now should he, the said Principal, faithfully perform all and singular his duties as a contractor during the term for which he has been licensed, and upon the terms required by the Building Code of Gwinnett County and by this bond, then the above bond is to be void; else to be of full force and effect.

PROVIDED FURTHER, that regardless of the number of years this bond shall continue or be continued in force and of the number of premiums that shall be payable or paid, the Surety shall not be liable hereunder for a larger amount, in the aggregate, than the amount of this bond, and;

PROVIDED FURTHER, that if the Surety shall so elect, this bond may be cancelled by the Surety as to subsequent liability by giving thirty (30) days notice in writing to said Principal and Chief Building Inspector of Gwinnett County.
