WHEREAS, the Building Code of Hall County, Georgia, as amended, contains regulations as to locating and relocating mobile homes and relocatable homes in Hall County, Georgia; and

WHEREAS, said Building Code further provides that: "It shall be the duty of every contractor who shall make contracts for the location of mobile homes or relocatable homes for which a permit is required, and every contractor subletting the same, or any part thereof, to obtain where required by State law or local ordinance or resolution, a current and valid Business Tax Certificate, Business License or Occupation Tax Certificate reflecting the payment of all occupation taxes; and it shall be the further duty of every such person to give good and sufficient bond in the sum of Ten Thousand Dollars (\$10,000.00), to be approved by the County Attorney, conditioned to conform to the Building Code and other ordinances or laws of the governing body in reference to mobile homes and relocatable homes."

WHEREAS, said Building Code was adopted for the purpose of providing safe homes and residences in Hall County and for the protection of residents of Hall County; and

WHEREAS, this bond is made, given, and executed for the benefit of anyone locating or relocating a mobile home or relocatable home in Hall County;

KNOW ALL MEN BY THESE PRESENTS:

as Surety, and heirs, executors, administrators and successors, are held and firmly bound unto Hall County, Georgia, in the full sum of TEN THOUSAND DOLLARS (\$10,000.00).

The condition of this obligation is such that whereas said Principal locates and relocates mobile homes and relocatable homes for others in Hall County, and if said Principal shall locate or relocate mobile homes or relocatable homes for others, and in all respects performs said locating or relocating in conformance with the Building Code of Hall County as amended, the Hall County Zoning Regulations, and faithfully performs work therein to comply with said Building Code and Hall County Zoning Regulations, this bond to be of no force or effect, otherwise in full force and effect.

This bond is made for the benefit of any person, corporation, partnership, cooperative or others having a mobile home or relocatable home located in or relocating in Hall County, Georgia.

The Surety has the right to terminate this bond upon thirty (30) days written notice to the Clerk of the Board of Commissioners of Hall County for any future acts, subsequent to said thirty (30) days.
