The conditions of this bond are such, that whereas the said \_\_\_\_\_, Principal, has been granted a permit or license by the said City of Hattiesburg to operate therein as a \_\_\_\_\_ contractor under the rules, regulations and ordinances adopted by the Council of said City in force and effect under the applicable laws of the State of Mississippi, and will hereafter, from time to time, apply for and be granted permits to do particular work and operations thereunder.

Now, therefore, if the above bound principal shall faithfully perform all work under the said license and:

Do and perform all work in connection with the erection, construction or maintenance required under each and every permit granted under the said license in accordance with the Southern Building Code and any and all City, State and/or Federal codes, laws and/or ordinances;

Pay all permit and inspection fees due said City;

Make all installations required under any permit granted in accordance with the Southern Building Code and any and all City, State and/or Federal codes, laws and/or ordinances.

all therefore strictly in accordance with the terms thereof, and with the rules and regulations and ordinances of the City of Hattiesburg, including all Ordinances, Codes and Amendments thereto, and the laws of the State of Mississippi.

Principal shall further pay to the City of Hattiesburg the sum of One Hundred Dollars (\$100.00) as liquidated damages for each and every violation of any of the provisions of said permit and the rules and regulations and Ordinances of the City of Hattiesburg and of the laws of the State of Mississippi in the erection, construction, maintenance, or installation of. In addition thereto, shall indemnify and save harmless the City of Hattiesburg, its officers and agents from any and all claims, damages, suites, actions or causes of action arising from or growing out of any act done in violation of the said permit and the rules, regulations, ordinances and laws, then this obligation shall be null and void; otherwise to remain in full force and effect.

It is agreed and understood, however, that the said contractor shall be given five (5) days to rectify or remedy any and all claims, damages, suites, actions or causes of action arising from or growing out of any act done in violation of the said permit and the rules, regulations, ordinances and laws, and upon his failure to do so, demand will be made for payment of the liquidated damages herein provided for.

It is further provided that this bond may be canceled by the surety upon written notice of cancellation delivered to the Land Code Administrator provided, however, that such cancellation shall not affect any liability which has theretofore become fixed, and shall not affect permits theretofore granted, the work under which has not been completed.
