NOW, the conditions of this obligation are such that whereas, the above bounded principal obligor  
has made an application for a license to carry on the business or trade of street-cuts, construction, or  
alteration of driveways connecting to the street contracting within the City of Del City, for the period of the

requirements thereunder are hereby made a part of the obligations of this BOND, and are to be  
Performed by the principal hereof as thought fully transcribed herein, and that the principal obligor will  
indemnify and save harmless the said City from all damages resulting from or in any way growing out of  
any injury received by any one on account of the negligence of unskilled work on the part of the principal  
obligor.

faithfully perform all the duties appertaining to such occupation fully in accordance with the ordinances  
herein mentioned while doing or following said occupation or business within the corporate limits of the

the rules and regulations of the lawful officers of said City, and with all ordinances of said City above  
referred to, and shall pay all fines and penalties imposed for a violation of any of said ordinances and  
shall indemnify and save harmless the said City from all damages resulting from or in any way growing  
out of any injury received by anyone on account of negligence or unskilled work, on the part of the  
principal obligor, then this obligation be void and of no effect, otherwise to remain in full force and virtue.

pursuant to any and all applicable laws of the State of Oklahoma.

NOW, the indemnity bond, and the terms of this contract, shall not be interpreted in any way so  
as to create any obligations to any third person on the part of the City of Del City
