

HOUSE MOVER'S BOND

KNOW ALL MEN BY THESE PRESENTS:

THAT _____ of Enid, Oklahoma,

as Principal, and _____, as Surety, are held and firmly bound under the City of Enid, Oklahoma, a municipal corporation, in the sum of Five Thousand Dollars (\$5,000.00), lawful money of the United States of America, for the payment of which well and truly to be made, we bind ourselves, our heirs, executors, administrators and assigns, jointly and severally and firmly by these presents.

Now, the conditions of this obligation are such that whereas the above named Principal herein has made an application for a license to carry on the business of house moving within the City of Enid, Oklahoma, for a period of twelve months beginning on the _____ day of _____, _____, and ending on the _____ day of _____, _____, under and pursuant to the regulations of the ordinances of said City, regulating and licensing the trade or occupation of house moving; and whereas the above mentioned Principal guarantees upon the granting of said license that he will comply faithfully with the provisions of said ordinances in all respects, and will also comply fully with all other ordinances of said City affecting such business or occupation which may now exist or which may be passed by the lawful authority of said City during the continuation of said license; and such ordinances of said City affecting said business or occupation are hereby made a part of this obligation of this bond and are to be performed by the Principal as fully described herein.

Now, if said _____ Principal herein shall fully and faithfully perform all the duties pertaining to such occupation in accordance with the ordinances herein mentioned while doing or following such occupation or business within the corporate limits of the City of Enid, and if said Principal shall save the City of Enid harmless any damages to the streets of the City of Enid and to any property of the City of Enid; and if said Principal shall pay any and all damages which may be caused to any person or property, either public or private within the City when such injury or damage shall be inflicted by said licensee or his agents, servants, employees, workmen, contractors or subcontractors; and if said licensee shall save, indemnify and protect the City of Enid from all liability which may arise, either directly or indirectly from the moving of any such building or structure as may be moved by said licensee, and if said licensee shall in all respects comply with the ordinances of said City in regard to moving of buildings and to the use of or obstruction of the streets or public places; then this obligation shall be void, otherwise to remain in full force and effect.

This bond is for the benefit of the City of Enid, Oklahoma, and any person or corporation sustaining injury or damage under the conditions thereof; and said City or any such person or corporation shall be entitled to sue thereon.
