KNOW ALL MEN BY THESE PRESENTS: That we, \_\_\_\_\_

as Surety, are held and firmly bound unto The City of Oklahoma City, a Municipal Corporation of the State of Oklahoma, in the sum of ONE THOUSAND and No/100 (\$1,000.00), Dollars, lawful money of the United States of America, for the payment of which, well and truly to be made, we bind ourselves, our successors, heirs, executors, administrators and assigns, jointly and severally, firmly by these presents. Now the conditions of this obligation are such that whereas, the above bounded principal obligor has made an application for a Certificate of Registration and/or license to carry on the business or trade of installing, constructing, repairing and/or extending small sewage treatment systems within the City of Oklahoma City, for the period of registration and/or license paying year within said City beginning \_\_\_\_\_, and ending \_\_\_\_\_, under and pursuant to the requirements of the Codes of said City regulating and registering the trade or occupation of installing, constructing, repairing and/or extending small sewage treatment systems, above mentioned and in which application guarantees, upon the granting of said Certificate of Registration and/or license that he will comply faithfully with the provisions of said Code in all respects and will also comply fully with all other Codes relating to small sewage treatment systems in said City. The principals or licensees and holders of Certificates of Registration covered by this bond will restore or cause to be restored with same material and in same manner as before, any and all streets, alleys, sidewalks, curbs, gutters or public highways in said City in any way disturbed by said licensee and that said principals or licensee and holders of certificate shall save the City harmless for any and all damage resulting from or in any way growing out of personal injury or property damage received by anyone on account of negligence or unskilled work on the part of said licensee, his agents or employees.

Now, if the said \_\_\_\_\_ principal obligor shall fully and faithfully perform all the duties appertaining to such occupation fully in accordance with the Codes herein mentioned while doing or following said occupation or business within the corporate limits of the City Oklahoma City and if said principal obligor shall during the term of said Certificate of Registration and/or license, faithfully comply with all the rules and regulations of the lawful officers of said City and with all the Codes of said City above referred to and shall pay all fines and penalties imposed for a violation of any said Codes and shall restore or cause to be restored with the same material and in the same manner as before any and all streets, alleys, sidewalks, curbs, guttering or public highways in said City in any way disturbed by said principal obligor, and shall save said City harmless from any and all damage resulting from any way growing out of any injury received by anyone on account of the negligence or unskilled work on the part of principal obligor or the agents or employees of said principal obligor, then this obligation to be void and of no effect, otherwise to remain in full force and virtue.
