

**TREE TRIMMERS BOND**

KNOW ALL MEN BY THESE PRESENTS: That we, \_\_\_\_\_, as Principal, and \_\_\_\_\_, as Surety, are held and firmly bound unto the City of Shawnee, a municipal corporation of the State of Oklahoma, in the sum of One Thousand Dollars (\$1,000), lawful money of the United States of America, for the payment of which, well and truly to be made, we bind ourselves, our successors, heirs, executors, administrators and assigns, jointly and severally, firmly by these presents.

Now the conditions of this obligation are such that whereas, the above bounden Principal obligor has made an application for a license to carry on the business or trade of tree trimmer within the City of Shawnee, beginning \_\_\_\_\_, \_\_\_\_\_, and ending \_\_\_\_\_, \_\_\_\_\_, under and pursuant to the requirements of the ordinances of said City regulating and licensing the trade or occupation of tree trimming, above mentioned, and in which application the applicant guarantees, upon the granting of said license, that he will comply faithfully with the provisions of said ordinance in all respects and will also comply fully with all other ordinances of said City affecting such business or occupation, which may now exist or which may be passed by the lawful authorities of said City during the continuation of said license, and such ordinance and all other ordinances of said City, affecting said occupation are hereby referred to and incorporated in, and all requirements thereunder are hereby made a part of the obligations of this bond and are to be performed by the Principal hereof as though fully transcribed herein.

The condition of the above obligation is such that whereas, the Principal \_\_\_\_\_ is engaged in the business of tree trimming in the City of Shawnee, Oklahoma, that the said \_\_\_\_\_, as Principal herein, shall save and keep harmless the City of Shawnee from all costs, damages or expenses of any kind whatsoever which may be suffered by the City of Shawnee or any of the inhabitants thereof because of the negligence on the part of such Principal in trimming trees, or any other act of omission in conducting such business, and further conditioned that the said Principal shall well and skillfully fully execute all of his work in said business in strict conformity with the ordinances, rules and regulations which have been or may be hereafter established by the City of Shawnee, Oklahoma, governing said work, and that he will cause all streets, alleys, and sidewalks which have been impaired in any manner to be repaired and put in the same condition as they were before the work was done, then these presents shall be null and void, otherwise, remain in full force and effect.
