KNOW ALL MEN BY THESE PRESENTS:

As Surety, are held and firmly bound unto the North Carolina Wildlife Resources Commission, as OBLIGEE, in the penal sum of Five Thousand Dollars (\$5,000.00), lawful money of the United States to be paid to the said Obligee, for which payment well and truly to be made, we hereby bind ourselves and our legal representatives, jointly and severally, by these presents.

The CONDITIONS of this bond as such:

That whereas, the said Principal has applied for an appointment by the Obligee as an agent for the sale of hunting, trapping, and fishing licenses, and has agreed to hold said Obligee harmless from suffering any loss or damage occasioned by the said Principal's failure to (1) safely keep such licenses pending the sale thereof, (2) truly account at face value for any of such licenses that may become lost or remain unsold, or (3) promptly remit to the Obligee the net proceeds (face value less appropriate issuing fees) received from all such licenses that shall be sold; and

Whereas, the said Principal has agreed to participate in a basic or blanket bond for such license agents providing primary protection to the said Obligee against any loss occasioned by the Principal in the amount of Four Thousand Dollars (\$4,000.00) so that this bond provides protection only against any such loss occasioned by the said Principal in excess of such primary protection.

Now, Therefore, if the said Principal shall faithfully perform all the duties of an agent for the sale of hunting, trapping and fishing licenses in accordance with the requirements of the Obligee and shall protect the said Obligee against any loss exceeding the amount of the primary protection provided by the basic or blanket bond referred to above, then this obligation shall be null and void; otherwise, the same shall remain in full force and effect.

This bond may be terminated by the Surety by sending written notice of its intention to terminate by registered or certified mail, return receipt requested, to the Principal at the address first above indicated and to the Obligee at the Archdale Building, 512 N. Salisbury Street, Raleigh, NC and at the expiration of thirty (30) days from the receipt of said notice by the Obligee, this bond shall terminate and the Surety shall thereupon be relieved from any liability for any subsequent acts or omissions of the Principal. Otherwise, this bond shall expire at midnight April 30, _____, unless renewed by a continuation certificate executed by the Surety.
